

# TERMS AND CONDITIONS OF USE

## Introduction

These terms and conditions apply between you, the User of this Website (including any sub-domains, unless expressly excluded by their own terms and conditions), and GoGet, the owner and operator of this Website. Please read these terms and conditions carefully, as they affect your legal rights.
